

NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio Transmission Company representatives plan to build 1.4 miles of 138-kilovolt (kV) power line between two electrical stations off Beech Road in Licking County.

The new power line connects the existing Anguin Station to the proposed Brie Station that company representatives filed with the Ohio Power Siting Board (OPSB) in September under Case No. 22-0799-EL-BLN.

The new power line supports economic development in the area. Company representatives filed a Letter of Notification with the OPSB as the Anguin-Brie 138 kV Transmission Line Project, Case No. 22-1029-EL-BLN. The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code.

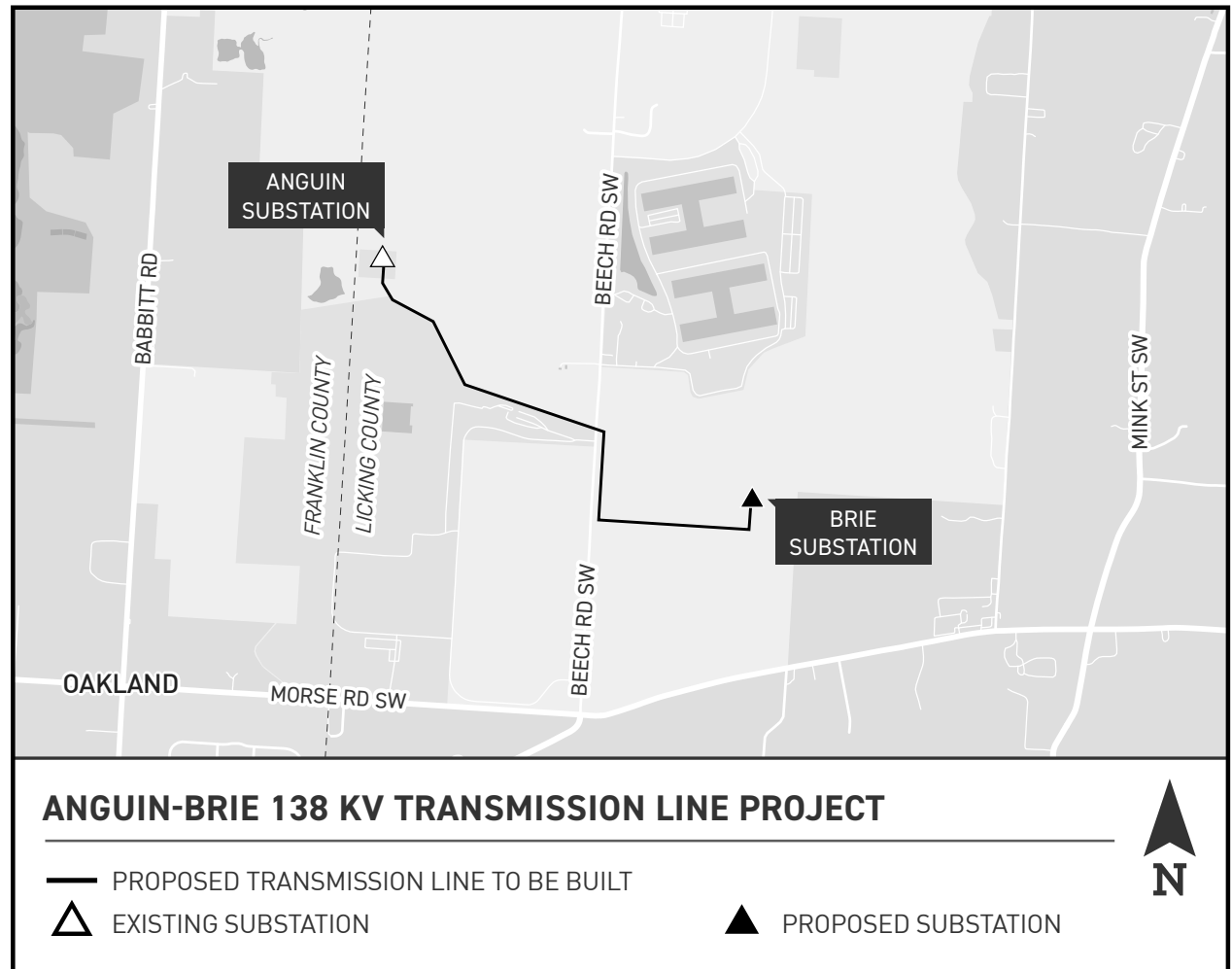
