NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio Transmission Company (AEP Ohio Transco) is proposing to improve the transmission system in Muskingum County by installing a new 0.9-mile double-circuit electric transmission line that loops the existing Philo-Howard 138-kV transmission line to the Ohio Central Substation.

The purpose of the project is to help alleviate the loading on the Ohio Central 138-kV circuits if an outage would occur on any of the existing 138-kV circuits. This will improve system reliability in the area and provide flexibility to system power flows. Construction is scheduled to begin in June 2014.

The project is known as the Ohio Central 138kV Loop Project. As required by Ohio Revised Code Section 4906-11-01, AEP Ohio Transco has filed a Letter of Notification with the state of Ohio Power Siting Board. The case number is 14-0053-EL-BLN.

The project meets the requirements for a Letter of Notification because the project is within the types of projects defined by Item (1) (d) of the Interim Application Requirement Matrix for Electric Power Transmission Lines in Appendix A of 4906-1-01 of the Ohio Administrative Code. These items state:


(1) Rerouting or extension or new construction of single or multiple circuit electric power transmission lines:
(d) Lines one hundred twenty-five (125)-kV and above, but less than three hundred (300)-kV, and greater than 0.2 miles in length but not greater than two miles in length.

The Letter of Notification for the Ohio Central 138-kV Loop Project is pending before the Ohio Power Siting Board. This application has been assigned Case No. 14-0053-EL-BLN. This number should be included in all communications with respect to this proceeding.

Petitions to intervene in or comment on the Letter of Notification will be accepted by the siting board up to 10 days following the publication date of this notice required by Rule 4906-5-08(C)(1), OAC. Petitions should be addressed to Ohio Power Siting Board, 180 East Broad Street, Columbus, Ohio, 43215-3793 and must cite the above-listed case number.

The Ohio Central 138-kV Loop Project involves the installation of 10 galvanized steel poles on concrete foundations. Five of the poles will be dead-end structures, and five poles will be tangent structures. New conductors, insulators and hardware will be installed on the new structures.

The project will be an approximate \$2.1 million investment by AEP in its transmission system in the area. The project will allow AEP to continue to provide the level of service its customers expect.



The accompanying map depicts the project area. It should be noted that due to the reduced scale and limited detail, this map should be used only as a general guide.
