

TILLOTSON AVENUE TRANSMISSION LINE PROJECT

Indiana Michigan Power representatives plan power grid upgrades to improve electric reliability for customers in northwest Muncie. Construction occurs in phases between 2024 and 2026.

CONSTRUCTION FAQ

PROJECT COMPONENTS & BENEFITS

- Rebuilding about 1 mile of underground transmission line on Tillotson Avenue between Bethel Substation, located near the intersection with W Riverside Avenue and Kenmore Substation, off North Elizabeth Avenue
- Upgrading about 3 miles of transmission line between Bethel Substation and Delaware Substation, off North Shaffer Road.
- Retiring about 1 mile of transmission facilities between Delaware Station and West Twickingham Drive. Lower-voltage distribution wires, third-party utilities and associated poles may remain.

CONSTRUCTION SCHEDULE

- Bethel - Kenmore Stations underground construction: Early 2024 - Late 2024
- Bethel - Delaware Stations: Summer 2024 - Summer 2025
- Delaware Station - West Twickingham Drive Retirement: Summer 2025 - Early 2026

WORK HOURS

Typical work hours are 7 a.m. - 7 p.m. weekdays

WHAT TO EXPECT DURING CONSTRUCTION

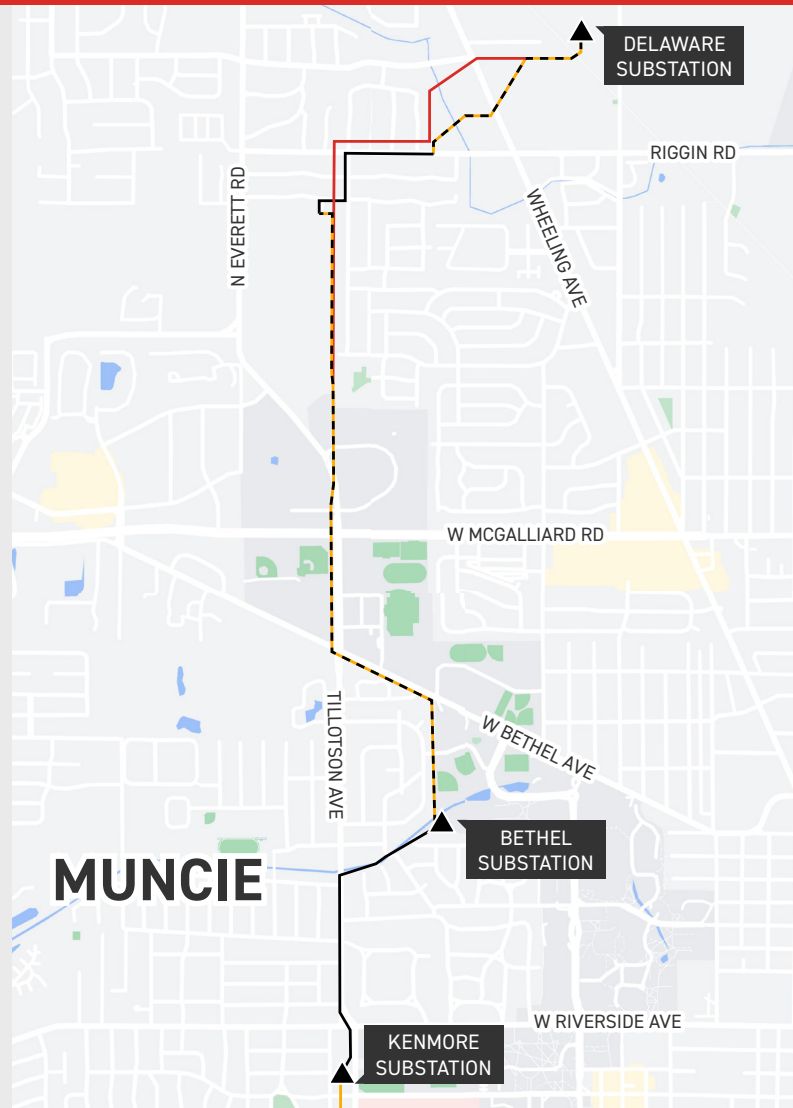
- Crews working on and alongside the road
- Advanced notice of work on private property
- Use of heavy construction equipment such as cranes, dozers and dump trucks
- Increased noise, dust and vibration and during work hours
- Increased travel time through the work zone

TRAFFIC CONTROL

- Daytime vehicle lane closures, reduced lane widths and sidewalk detours along Tillotson Avenue.
- Offsite detours of intersecting streets when work occurs at intersections.
- Temporary steel plates and asphalt patches on the road outside of work hours.
- Safety signage and flaggers to aid traffic flow.

SAFETY TIPS

- Keep your distance from construction workers and equipment
- Stay outside of temporary safety barriers
- Be aware of uneven or slippery surfaces
- Slow down when driving in the area and use headlights
- Watch for posted signs
- Watch for road closures and traffic detours
- Follow flaggers' instructions
