

NOTICE OF PROPOSED ELECTRICAL UPGRADES

AEP Ohio officials have proposed an electrical transmission project in Pickaway County.

AEP Ohio representatives plan to provide temporary power to a customer's delivery point in Madison Township, Pickaway County. The project involves building .1 miles of 138-kilovolt (kV) transmission line, installing a switch pole, and rebuilding three existing H-frame structures with two steel monopoles.

These improvements provide temporary service to a customer and allow for future upgrades in the area. If approved, crews expect construction to begin in December and conclude in March 2026.

AEP Ohio representatives have filed a Letter of Notification with the Ohio Power Siting Board (OPSB) as Endor 138kV Switch Project Case No. 25-1006-EL-BLN. The Letter of Notification to construct, operate and maintain the new switch and line awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. The Letter of Notification to construct, operate and maintain these facilities awaits OPSB review.
