
## NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio representatives plan to build Rocky Ford Station, near the intersection of Township Road 238 and County Road 216 in Cass Township, Hancock County, Company representatives also plan to build less than 0.2 miles of 138-kilovolt (kV) transmission line connecting Rocky Ford Station to a customer facility and an existing 138-kV transmission line. The company needs to build the station and transmission lines to serve a customer's facility and support their development plans. If approved, company representatives expect construction to begin in January and conclude late 2025.

AEP Ohio officials filed the following project components with the Ohio Power Siting Board (OPSB):

- Letter of Notification: Rocky Ford 138 kV Station Project, Case No. 24-0707-EL-BLN. Building Rocky Ford Station, near the intersection of Township Road 238 and County Road 216 in Cass Township, Hancock County.
- Construction Notice: Ebersol-Fostoria Central #2 138 kV Cut-In and Rocky Ford-Border Basin 138 kV Tie Line



Project, Case No. 24-0706-EL-BNR. Building less than 0.2 miles of 138-kV transmission line connecting Rocky Ford Station to a customer facility and an existing 138-kV transmission line.

The Letter of Notification and Construction Notice to construct, operate and maintain these facilities awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification and Construction Notice up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E.
