NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio officials have proposed an electric transmission line project in Delaware and Licking counties.

Representatives of AEP Ohio plan to build two 13-mile 345-kilovolt (kV) transmission lines between the existing Vassell Substation in Sunbury, Delaware County and the proposed Green Chapel Substation in Johnstown, Licking County. The improvements connect new customers to the electric grid and ensure continued reliable electricity for area customers. If approved, company officials expect construction to begin fall 2024 and conclude spring 2026.

AEP Ohio representatives have filed a Letter of Notification with the Ohio Power Siting Board (OPSB) for one of the two proposed 13-mile lines as the Vassell-Green Chapel 345 kV Transmission Line Project, Public Utilities Commission of Ohio Case No. 24-0014-EL-BLN. The company also plans to file a Letter of Notification for the second line in the future.

The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E.
