

NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio officials have proposed adjustments to an electric transmission line project in Delaware and Licking counties.

AEP Ohio representatives plan to build two approximately 13-mile 345-kilovolt (kV) transmission lines connecting the existing Vassell Substation in Sunbury to two proposed substations in New Albany. The improvements connect new customers to the electric grid and ensure continued reliable electricity for area customers. If approved, company officials expect construction of the first transmission line to begin early 2025 and conclude in spring 2026, and construction of the second transmission line to begin in early 2025 and conclude in spring 2027.

AEP Ohio representatives propose minor route adjustments and recently filed the following two Letters of Notification with the Ohio Power Siting Board (OPSB):

- Vassell-Green Chapel 345 kV Transmission Line Adjustment Project, Case No. 24-0791-EL-BLN.
Adjusting .7 miles along the first of two transmission lines, previously filed and approved as the Vassell-Green Chapel 345 kV Transmission Line Project, Case No. 24-0791-EL-BLN.
- Vassell-Curleys 345 kV Transmission Line Adjustment Project, Case No. 24-0792-EL-BLN.
Adjusting 4.1 miles along the second of two transmission lines, previously filed and approved as the Vassell-Curleys 345 kV Transmission Line Project, Case No. 24-0792-EL-BLN.

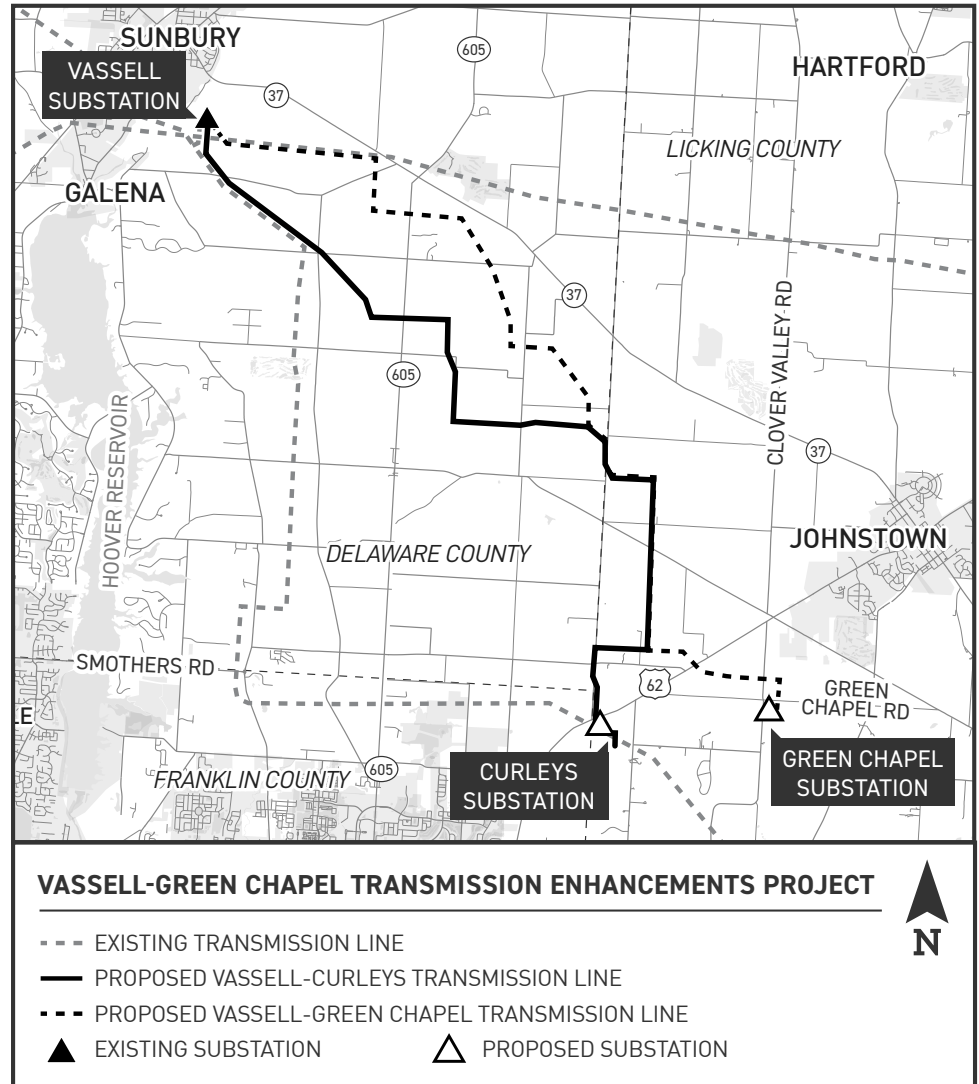
