

# NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio and AEP Ohio Transmission Company, Inc. (AEP Ohio Transco) representatives plan to build an electrical substation to support economic development and increase service reliability for customers in Muskingum County. The Culbertson 138-kilovolt (kV) Station Project involves building a substation on property owned by AEP Ohio located off Innovation Way in Washington Township.

Construction begins this summer and concludes in the fall.

AEP Ohio Transco representatives filed a Letter of Notification with the Ohio Power Siting Board (OPSB) as the Culbertson 138kV Station Project, Case No. 20-0542-EL-BLN. The Letter of Notification to construct, operate and maintain this facility awaits review by the OPSB.

The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene can be found in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E. Broad Street, Columbus, Ohio, 43215-3793 and cite Case No. 20-0542-EL-BLN.

Company representatives plan to file a separate Letter of Notification with the OPSB in the future to build 0.5 miles of transmission line to connect into the substation.

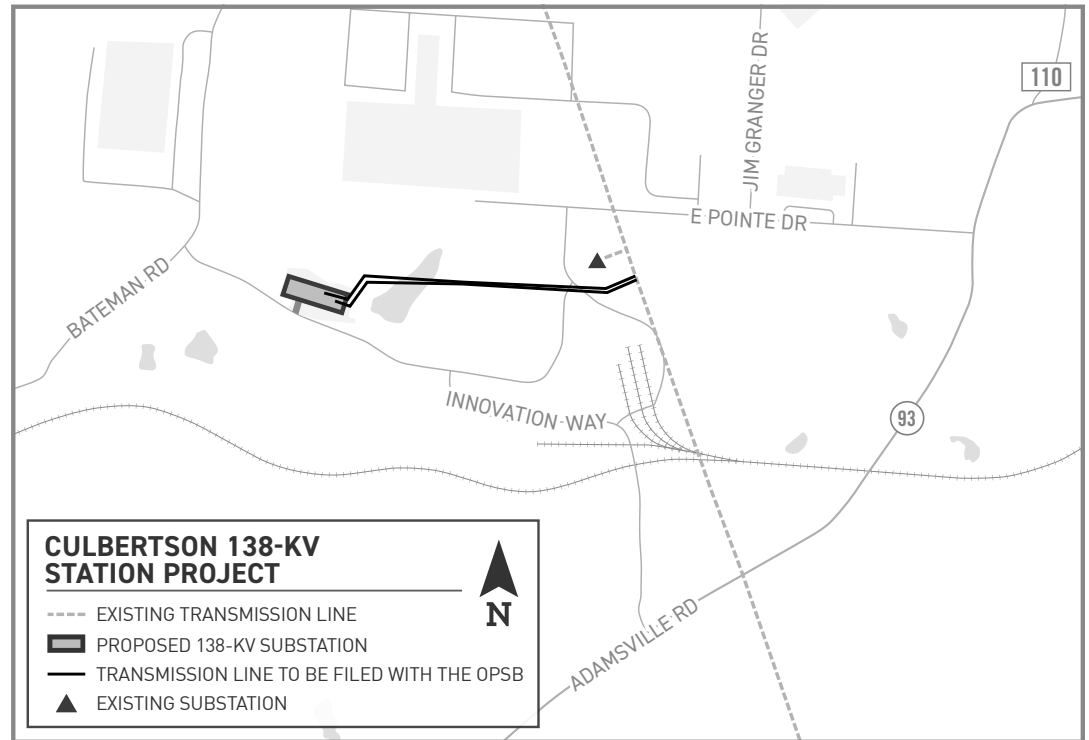
