

NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio representatives plan to adjust the location of about 0.4 miles of planned 345-kilovolt (kV) transmission line and associated transmission structures near Scioto Darby Road. Company officials plan to build the transmission line as part of the Beacon Station Project (previously filed as Case No. 23-0691-EL-BLN and 23-1050-EL-BLN). Shifting the location of the line and structures avoids conflicts with existing underground utilities. The project provides power to a customer substation and helps meet the area's growing demand for electricity.

Company representatives filed these changes with the Ohio Power Siting Board (OPSB) as the Adjustments to the Hayden-Roberts 345 kV Cut-In (Beacon Station) Project, Case No. 24-0630-EL-BLN.

The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E. 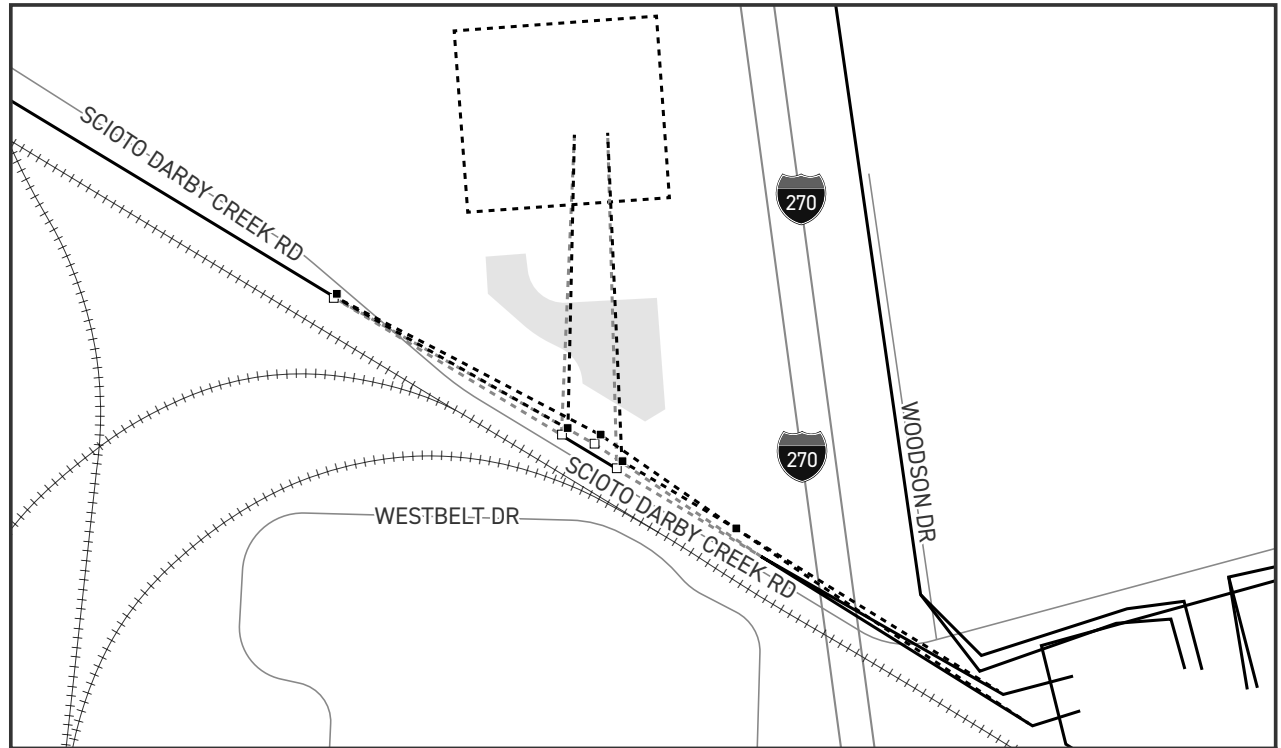
