

NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio Transmission Company Inc. (AEP Ohio Transco), an affiliate of AEP Ohio, proposes to replace an existing transmission substation with a new substation in York Township in Athens County.

This is the second public notice for this project. We are slightly shifting the location of the substation on our property.

The purpose of the Lemaster 138-kilovolt (kV) Station is to improve electric service reliability in Athens County and the surrounding area. The project involves replacing the Poston Substation with the new Lemaster Substation. The new substation will be built on property owned by AEP Ohio Transco adjacent to the existing substation. This project will be an approximate \$10 million investment by AEP Ohio Transco. Construction began in October 2017.

The project is known as the Lemaster 138-kV Station. AEP Ohio Transco filed a Letter of Notification with the Ohio Power Siting Board, under Case No. 16-XXXX-EL-BLN. This number should be included in all communications with respect to this project. The Letter of Notification to construct, operate and maintain this facility is pending before the board.

Petitions to intervene in the Letter of Notification will be accepted by the siting board up to 10 days following the publication date of this notice required by Rule 4906-2-12, Ohio Administrative Code. Petitions should be addressed to Ohio Power Siting Board, 180 East Broad Street, Columbus, Ohio, 43215-3793 and must cite Case No. 16-XXXX-EL-BLN.

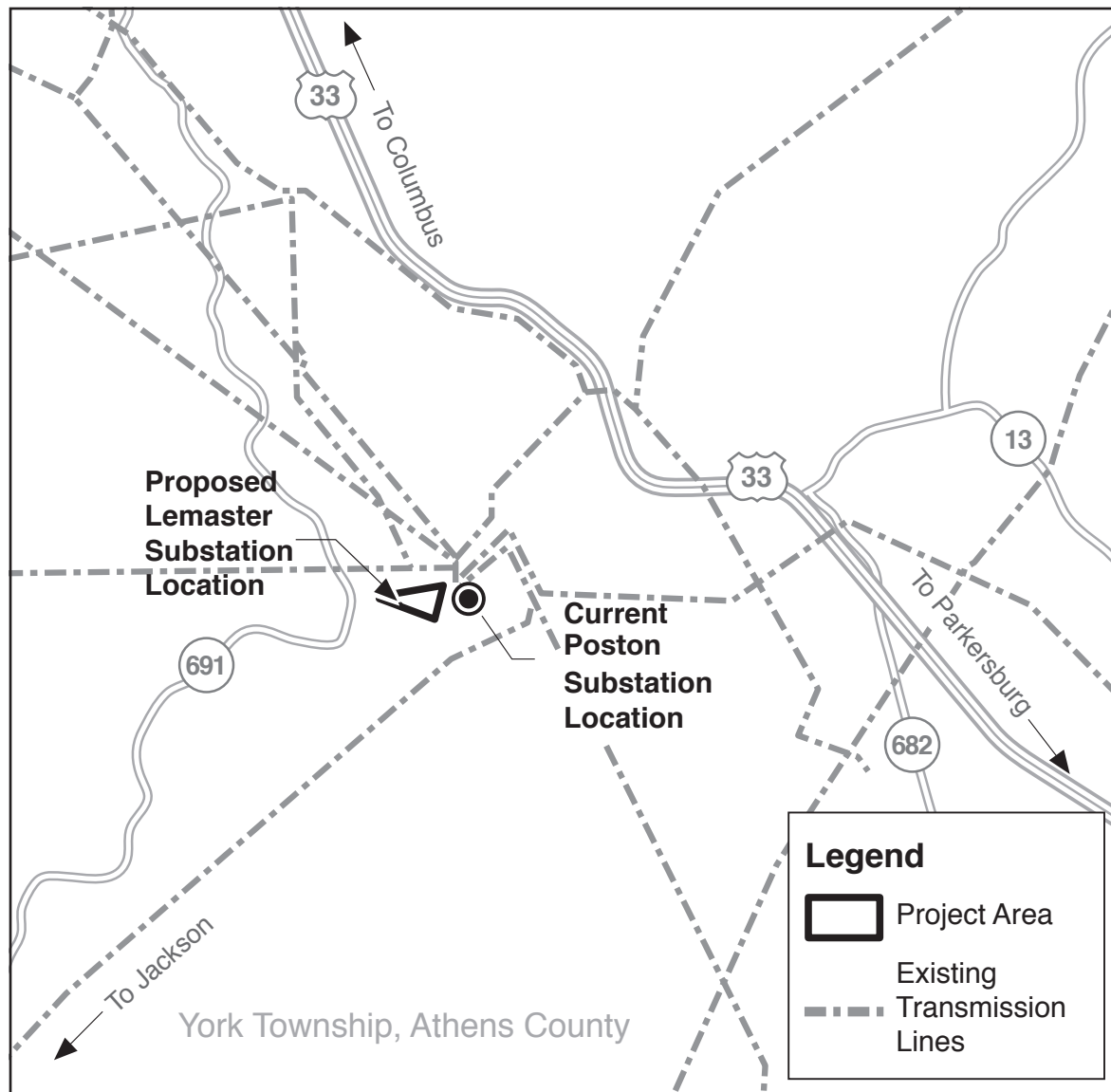
