
AEP Ohio and Ohio Power Company representatives plan power upgrades to accomodate a new development on Vine Street in Columbus.

The Vine - City of Columbus West 138 kV Transmission Line Relocation Project involves:

- · Relocating 0.3 miles of overhead power line underground along Vine Street in Columbus.
- · Adjusting one span of overhead power line.
- Installing two new poles to accommodate the power line transitions from overhead to underground.

Ohio Power Company representatives filed a Letter of Notification with the Ohio Power Siting Board (OPSB) as the Vine-City of Columbus West 138 kV Transmission Line Relocation Project, Case No. 22-0918-EL-BLN. The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. If approved, construction begins in November and concludes in fall 2023.

The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice.
